1. You must be an enrolled member of the Turtle Mountain Band of Chippewa Indians or an enrolled member of a North Dakota, South Dakota or Minnesota Indian Tribe. Copy of enrollment is required.
2. There is a \$25 application fee for Juried and Non-Juried participants. Application fee is non-refundable.
3. Booth fee for all participants will be \$50.00.
4. Youth juried participant may share a booth with parent or guardian.
5. You may enter 2 pieces per division, not to exceed 4 entries.
6. Artist or Artist representative must accompany art piece when registering pieces.
7. If piece is a collaborative piece, both artists must register.
8. Art piece must have been created in the last 2 years.
9. Juried Applicant must provide 3 images of work in the category he/or she is applying for.
10. Non-juried must provide 3 images of examples of work that will be sold.
11. Photos can be emailed or copied on to a CD or zip drive device.
12. Juried and non-juried must submit photos.
13. Photos and CD's will not be returned.
14. During the market the sale of t-shirts or beading supplies will be prohibited.
15. Award winners must set up booth or forfeit prize money.
16. Prize money will be awarded on Saturday at the conclusion of art market.
17. All entered pieces must be for sale.
18. TMTAA complies with the Indian Arts and Crafts Act of the Department of Interior.
19. TMTAA has the right to change or cancel any event.
20. TMTAA is not responsible for any accidents, travel, theft or damages.
